### **Teaching activities**

My teaching initiatives are guided by basic principles of critical theory, enabling students to make use of the knowledge acquired in class to reflectively examine their life-worlds. I have been teaching eight different undergraduate and postgraduate courses since arriving at Edinburgh in 2012, with on average 50 students. My teaching at Honours level includes classes on democratic theory, populism, and the ethics of warfare. On sub-Honours level, I teach on the introductory course to Political Theory, with more than 500 students. In terms of postgraduate teaching, I served for three years as the Programme Director of our School's MSc degree in International Political Theory, significantly reforming the degree, expanding its scope and raising student numbers. Currently, I am external examiner for the undergraduate degree in Politics and International Relations at Queen Mary, University of London. In 2021, I am a visiting lecturer for the MA degree in Political Philosophy at Pompeu Fabra University, Barcelona. Since 2013, I also serve as a regular invited professor at the University of Vienna's MA in human rights. Before joining Edinburgh, I have independently designed and run seven courses at three European universities (Vienna, Klagenfurt and Coimbra), and given lectures at two North-American universities (Arizona State and Toronto). My pedagogical activities have been recognized through sustained teachings award nominations and consistently positive student feedback (reports available upon request). I am also a fellow of the UK Higher Education Academy, having finished the Postgraduate Certificate in Academic Practice in 2014.
